#### DOSING METHOD:

Dispense the specified amount of product by pushing the button once on the e:dose dispenser to dose 10 ml or by using the 10 ml dosing cap on the 1 L bottle.

#### HARD WASHABLE SURFACES:

Add 1 x 10 ml dose to 600 ml water in an EC2 spray bottle.

Spray surface & wipe with clean damp cloth. Increase dosage for heavy grease.

#### DAMP MOPPING & GENERAL CLEANING:

Add 2 x 10 ml doses to 5 L warm water in a bucket.

Mop or wipe surface.
